# AUGUST PROGRAM: EAGAN

Do you want to learn a little more about Minnesota Dr Mark Seeley, climatologist weather? meteorologist from the University of Minnesota Department of Soil, Water and Climate will speak to us on "Climate Trends in Minnesota - Some Implied and Documented Impacts". Recent climate trends in Minnesota show a pronounced warming in the winter months, biased contribution in warmth from minimum temperatures, higher frequency of tropical like dew points, and an increase in annual precipitation. The change in winter temperature has both frequency and amplitude characteristics that have implications for soil and lake freezing. Minimum temperature trends have had impact on the biological environment as well as animal behaviors. Other consequential implications of these changes in climate characteristics will be discussed.

# SEPTEMBER PROGRAM: ROSEVILLE

For the September 14th program we'll have Gordon "Porky" Lee, from the Our Gang (Little Rascals) movie series, speak to us about his experiences working as a child actor on a movie set about 70years ago. # **HEALTH ISSUES**

#### **SOCIAL SECURITY UPDATE**

The Pozen Plan to ensure benefits are smaller in the future proposes substitute price indexing for wage indexing beginning in 2012; the President likes this for those earning over \$20,000. The plan also allows workers to voluntarily place 2% of their Social Security taxes in investment accounts that are projected to return about 4.8%. At retirement, the worker would convert the account to an annuity that would supplement regular Social Security benefits that have been cut by the percentage contributed to the voluntary account (see August, Consumer's Reports).

Another result would be the benefit cuts seen by surviving family members of workers who die before retirement. The Pozen Plan (President's Commission to Strengthen Social Security) would impose a 9.4% benefit cut for a worker who dies at age 45. Men in their twenties have a 30% chance of becoming disabled before retirement, and with a third of those likely to die before retirement. (28 June, Economic Policy Institute).

Worse is the DeMint Plan to use the current Social Security tax surplus to fund private accounts until the surplus runs out in a projected 11 years. The typical worker might accumulate \$3-5,000 in such an account – and owe the equivalent amount to the government. Many more workers would accumulate only a few hundred dollars in accounts, all of which would have to be managed until retirement and all subject to level of repayment to the government. This is a good chance to lose money and a sure way to accelerate the time when Social Security funds could no longer pay 100% of planned benefits – projected to be 2041 or 2052 (6 July, Economic Policy Institute).

Even though members of Congress have said they do not have time to find agreement on any Social Security proposals, both Rep. Thomas and Sen. Grassley are thought to have some form of reform bills available that would appear mostly reasonable and could actually be voted on. The fear is that if both houses passed an innocuous bill, a conference

committee could add private accounts or worse. Remember, a conference committee gave us the 2003 Medicare Modernization Act. The drug companies and health insurance companies got theirs with the MMA; Wall Street would get theirs with private accounts. Submitted by Brian Berggren

#### **CONSUMER DRIVEN SENIORS**

Consumer-driven is the latest and greatest direction for "Older Adult Services," according to a 2005 Minnesota Department of Human Services report. Projections have Minnesota's senior population tripling between 2000 and 2050; those over 85 will grow by a factor of six. Human Services also projects that the elderly dependency ratio will more than double. By 2030, 1.3 million persons will be 65 and older; 265,000 will be women living alone with limited family and personal resources and 180,000 will not have adequate income for health and longterm care costs. The good part of the report is the goal of reducing care through the institutional model (nursing homes) and expanding home care and residential options. The bad part is the financing options: five types of long-term care insurance products, reverse mortgages and family loans, and private savings for a care annuity. The Dept. of Human Services even considers Medicaid as something that crowds out private options. The report concludes by saying, "There needs to be a variety of options available to meet the differing circumstances of individuals and families." Is this just a polite way of saying you only get what you can afford? Submitted by Brian Berggren.



**Directions to Eagan Community Center**. Take Hwy 35E south or north to Pilot Knob Road. Turn left (north) on Pilot Knob Road. Turn left on Central Parkway (which is also the North entrance to Lockheed). The Eagan Community Center is at 1501 Central Parkway.

**Directions to Unisys in Roseville**. Take Hwy 35W south, or north, to the Industrial Way / St. Anthony Blvd off ramp. If coming north or south on Hwy 35E go west on Hwy 36 which will take you to the Industrial Way / St. Anthony Blvd. off ramp of 35W (Hwy 36 becomes Hwy 35W where it joins Hwy 35W). Go north on St. Anthony Blvd. to Walnut St. (the first street on the right). Turn right and go to Highcrest which is the first place where you can turn left. Past the stop sign. Bldg 3 is on the right. Gate 5 is in the center of the building.

From Hwy 280 northbound, use left lane exit just past Cty Rd B for Terminal road access (St Croix St.). Turn left at Terminal Rd, then turn right at Highcrest Rd to building entrance.
