Minnesota State Trooper John Thompson has often been a
first responder to many a crash as well as a crash
investigator and crash "reconstructionist." Trooper
Johnson, badge #230, will address the importance of
seatbelts, the "move over" law, inattentive driving and cell
phone usage. He has a power point presentation with lots
of good photos and stories from his personal experiences.
A Q&A period will follow.

Sgt. John Thompson became a Minnesota State Trooper in 1996. He completed additional training to become a Crash Reconstructionist in 1999 and joined the Metro Crash Reconstruction team in 2001. In 2004, Sgt. Thompson was ACTAR-certified (Accreditation Commission for Traffic Accident Reconstruction) which is the highest accreditation in crash reconstruction. Since becoming a Reconstructionist, Sgt. Thompson has investigated over 400 fatal/serious crashes. He also is an instructor at the Minnesota State Patrol Training Center and teaches a variety of courses on Crash Investigation and Vehicle Contacts. Sgt. Thompson is currently assigned to the 2510beat, the geographical area of Scott and Carver

Counties, in addition to his crash reconstruction work. Sgt. Thompson lives in Chaska with his wife Leann and three children Noah, Ellie and Isaac. He spends most of his off duty time coaching his kids in basketball and football.

#### **WEB SITE REVIEW** by Lowell Benson.

This is the twentieth in the Article-for-the-Month review series for Club members who don't have immediate internet access. If you don't have internet in your home, you could go to the public library to reread previous 'Articles for the Month', linked from <a href="http://vipclubmn.org/documents.aspx">http://vipclubmn.org/documents.aspx</a>.

In November 2010 we posted a high level technical description of the CP-754/A hardware and system design, authored by R. P. Blixt in 1963. The CP-754 was UNIVAC Type 1020, a modified AF type 1000 computer. "The first experimental version of the A-NEW data processing system, designated XN-1, was initiated by the Naval Air Development Center at Pennsylvania in December, Johnsville, Following the completion of a study program to determine the feasibility of the concept, UNIVAC was selected as a team member for the XN-1 program. UNIVAC's role on the SN-1 system was threefold: 1) to assist NADC in defining XN-1 functions, 2) to design and develop the required digital computing equipment, and 3) to develop the computer programs necessary to carry out the system functions. The target date for equipment delivery was 1 July 1963 and 31 October 1963 was established as the date for commencing the first flight tests with the equipment installed in a NP-3A aircraft (a modified Lockheed Electra). The delivery date was met by UNIVAC, the equipment being in operation at NADC on 2 July 1963."




Fig. 1 Block Diagram of A-New XN-1 Equipment

"The digital computing equipment supplied by UNIVAC consists of the following: 1) CP-754/A Computer, 2) Computer Peripheral Control Unit (CPC), 3) Buffer Core Memory, 4) Perforated Tape Reader, 5) Magnetic Tape Recorder, and 6) Computer Maintenance Test Bench. The CPC logic chassis is physically the same as that of a UNIVAC 1218 Computer, employing the same type of logic cards except for a few special input-output matchers. The other major components of the SN-1 data-processing system include: 1) Tactical Situation Display with operator controls, 2) Sensor Operators' Keysets, 3) Ordnance Display and Control, Receiver/Transmitter Control, and 5) Pilot's Display."



The equipment installation in the YP-3 aircraft is illustrated in this drawing from the description document. "As in most data-processing systems, operation is centered around the digital computer. The computer software is responsible for integrating the inputs received from the various ASW sensors, determining the optimum tactics to employ, executing the tactic, computing the probability of success or failure, and navigating the aircraft. UNIVAC developed seven program modules: 1) navigation, 2) search and correlation, 3) contact conversion, 4) automatic tracking, 5) extend track, 6) attack, and 7) post flight analysis." "At the completion of each flight,

the magnetic tapes will be read on a ground-based UNIVAC 1206 Computer." By L.A. Benson

#### PHOTO SLEUTHS WANTED

Many of you are aware that there has been an ongoing effort to capture historical material from the Lockheed Eagan facility, which has been the repository for material dating back to ERA, and includes Twin Cities (Defense and Commercial) Univac/Sperry/Unisys info right up to the purchase by Lockheed in 1996.

Lockheed will vacate the building, which has been sold, early in 2013 so 2012 becomes the year when we have to get all the material out of there. Most of it will end up at the Charles Babbage Institute (CBI) at the U of M.

As part of this effort, we have "inherited" a huge (thousands of images) photo archive. CBI is very interested in these photos, but has cautioned us that their value is diminished without some documentation as to what they represent, which is generally missing from our archive. To date, volunteers have been manually looking at photos (all forms - negatives, slides, transparencies and prints), attempting to identify the subject, and entering the data in a database. It is clear that we need to greatly expand this effort if we are to finish in 2012.

We envision a series of work days like we put together for the patent data wherein a group of people would work in the Eagan facility, individually taking a group of photos and entering pertinent data into an Excel database. We need to secure some additional resources (access to PC and light boxes) before we start, but we would like to collect our volunteer pool ASAP, so we can arrange schedules and facility access early on 2012.

So, if you are interested in having a good time doing a some photo detective work, please email Harvey Taipale (hjtaipale@comcast.net) with your interest and availability and we will further coordinate via email early in 2012. **Directions to Unisys MACS Bldg. in Eagan.** Take Hwy 35E south or north to Pilot Knob Road. Turn left (north) on Pilot Knob Road. Turn left on Tower View Road. The Unisys MACS Bldg. is at 3199 Pilot Knob Road.

**Directions to Unisys in Roseville**. Take Hwy 35W south, or north, to the Industrial Way / St. Anthony Blvd off ramp. If coming north or south on Hwy 35E go west on Hwy 36 which will take you to the Industrial Way / St. Anthony Blvd. off ramp of 35W (Hwy 36 becomes Hwy 35W where it joins Hwy 35W). Go north on St. Anthony Blvd. to Walnut St. (the first street on the right). Turn right and go to Walnut Street. It is the first place where you can turn left. Then turn left onto Terminal Road. Then turn right at Highcrest Rd. to building entrance. From Hwy 280 northbound, use left lane exit just past Cty Rd B for Terminal road access (St Croix St.). Turn left at Terminal Rd, then turn right at Highcrest Rd to building entrance."
