### FEBRUARY PROGRAM AMTRAK and the EMPIRE BUILDER

**February 10<sup>th</sup>, 7:00 PM:** Please join us at the UNISYS, Roseville Superior conference room to hear about "AMTRAK and the Empire Builder".

Don Anderson is a station agent for Amtrak in St. Paul. He has worked all over the Midwest in various capacities in the past twenty-five years. (Flexibility and improvisation is a key requirement in passenger railroading.) He is a 1982 graduate of the University of Minnesota Twin Cities campus. Prior to Amtrak he worked for several banks in dealer finance and asset management.

Don's presentation will focus mainly on the Empire Builder route which runs through the Twin Cities between Chicago and Seattle. He will also give a bit of a historical narrative since the train has run continuously since 1927 and is considered by many to be a railroading icon and a part of our national hagiography. He'll also have sample fares and route maps. The presentation also describes different classes of service available and highlights of the route. #### MARCH PROGRAM Air Traffic Control Part II

**March 9<sup>th</sup>, 7:00 PM:** Please meet with us for coffee, cookies, and a talk by Steve Koltes. In September of 2014 the VIP Club monthly program, presented by Steve Koltes, covered the first 50 years of our company's involvement in air traffic control. Our customer, the Federal Aviation Administration (FAA) has clearly been satisfied with our efforts and rewarded and challenged us with continued tasks to improve and advance the hardware and software systems of Air Traffic Management (ATM) as it is now called. Steve's

effort, which was held at the LM facility in Eagan, drew a large crowd, many of whom had worked in the ATM group. In our March program, again held at the MN Eagan facility, Steve will present Part II which will build on the history of our first half century and discuss Lockheed Martin's current and future efforts assuring safe and efficient air travel.

Background: In 1964 our first air traffic control system was deployed at the Atlanta, GA airport. It was the result of the FAA's development "Project Beacon" and our company's efforts for NTDS. It was known as the first Automated Radar Terminal System (ARTS I). ARTS evolved to ARTS III and in 1969 the FAA gave us the green light, project build and install the ARTS III system at 64 major U.S. sites. Over time the systems were enhanced and expanded to include many other airports domestically and internationally (see http://vipclubmn.org/aircontrol.html).

# **REPORTS, LEGACY ACTIVITIES**

**70 Years Ago**, **January 1946**: In recognition of the beginning of our Twin Cities Information Technology (IT) Legacy, for the January 'Article for the Month' we are posting *William C. Norris' WWII Experiences*. An extract from page 12 "Since the history of ERA has been well publicized, I won't repeat it here, except for three aspects. One is the name, which initially was Research and Development Associates. We hoped it projected an image of a technically oriented company where there was extensive employee ownership. After using the name for a time, it finally dawned on us that an abbreviation by competitors would likely be RED ASS. Needless to say, we didn't want to take that risk, so we changed it to Engineering Research Associates.

Second, ERA was one of two companies that launched the computer industry. The other was Eckert-Mauchly in Philadelphia, which was established during June 1946, six months after ERA. Interestingly, Engstrom and I met with J.P. Eckert during our search for funding. He and John Mauchly were also having difficulty arranging for financing. We offered to join forces, but Eckert declined. Ironically, we came together later when Remington Rand acquired EMC in 1950, and in 1952 acquire ERA. These two companies constituted the Univac Division of Remington Rand. In 1955 Remington was acquired by the Sperry Corporation to form Sperry Rand. I was given the job as general manager of the Univac division of Sperry Rand."

70 Years Ago, February 1946: "The first general purpose electronic calculator was formally dedicated at the MOORE School of Engineering at the U of Pennsylvania in Feb 1946." "Built to do ballistic calculations for the US Army, it was named the Electronic Numerical Integrator and Computer, and called after its initials the ENIAC".

In recognition of this event, Bill Mauchly is coordinating celebration events and displays at the University of Pennsylvania and a few other sites in the Philadelphia area on February 15<sup>th</sup>.




# VIP Club January/February 2016 Newsletter OLD TIMERS' REUNION ON DECEMBER 3<sup>rd</sup>.

Car-pool if possible to all events or contact a board member for possible 'ride-with' suggestions.


Directions to UNISYS in Roseville: Set your GPS unit to Roseville MN, 2470 Highcrest Road. From Hwy 35W north; exit onto W County Rd C



to go west a mile, then turn left onto Walnut St. Then turn right onto Terminal Road for half a block, turn right at Highcrest Rd. to building entrance. From 35W south, exit on Industrial Way / St. Anthony Blvd off ramp, turn left, drive under the freeway, then turn right onto Walnut St. Follow it 0.8 mi north then turn left on Terminal Road. Go <sup>1</sup>/<sub>2</sub> blocks and enter the UNISYS parking lot on the right. From Hwy 36 east, drive west until 36 joins Hwy 35W just past Hwy 280, then exit at the Industrial Way / St. Anthony Blvd. off ramp of 35W. Go north on St. Anthony Blvd. to Walnut St. [the first street on the right]. Turn right onto Walnut Street.

**Directions to Unisys MACS in Eagan**: Set your GPS unit to Eagan MN, 3199 Pilot Knob Road. <u>From Hwy 35E</u> take the Pilot Knob Road exit ramp. Then go north on Pilot Knob Road about ½ mile to Tower View Road. We use the Unisys north parking lot and the visitor entrance thereby.





**Directions to the Lawshe Museum in South St. Paul:** Set your GPS unit to South Saint Paul, 130 Third Avenue. <u>From the Roseville area</u>, take Hwy 36 to I-35E south toward downtown St. Paul. Get into the left lane then take the I-94/Hwy 52 left exit to merge onto

Hwy 52 going south. 3.4 miles later, take the Butler Ave exit and turn left. Go 0.7 mi and turn right onto MN156 S. After 1.8 mi, turn right onto Grand Ave. W – Drive up the hill a block and turn left, the parking lot is then 400 ft. on the left. From the Eagan area, take I494 toward the Mississippi river then take exit #65 onto 7<sup>th</sup> Ave. Turn left and drive a mile to South view Blvd, turn right at the light. After 0.3 mi, turn left onto  $3^{rd}$  Ave – the museum parking lot is then 0.2 mi on the right.

**Directions to LMCO in Eagan:** Set your GPS unit to Eagan MN, 1303 Corporate Center Drive, Suite 100 Eagan, MN 55121. <u>From Roseville area</u>, take 35E south through St. Paul then exit to the west onto I-494. Then take exit 71 for Co Rd 31 (Pilot Knob Road) and go

south. *Turn left onto Corporate Center Drive*, then when you see the LMCO sign, turn left, start up the hill then turn left into the parking log - drive through the parking lot to the west side of the building and turn left into that parking lot section. Enter the building through the west door. From Minneapolis or Bloomington, get onto 494 going East then take exit 71 onto Pilot Knob Road going south - then follow the Corporate Center Drive instructions above.
