This year's speaker is Maya Rao, a staff writer for the Minneapolis Star Tribune since 2012. characterized herself as a "biracial East Coaster," having grown up on the East Coast, the product of an Asian Indian father and a European American mother, and never knew she had Minnesota roots, that is, until she moved here. For the Strib she wrote mainly about urban issues and Minneapolis City Hall, and then moved to the regional team covering Minnesota and surrounding states. Before working at the Strib, she wrote for newspapers on the East Coast since 2006, spending much of that time at the Philadelphia Enquirer. She will recount her surprising discovery of her Norwegian roots in Minnesota.



#### **SOCIAL ACTIVITY ITEMS**

**From the UNISYS Blue Bell Retirees' Group (UBBRG)**: For the edification of our VIP Club members, we have copied the President's message from the UBBRG March newsletter.

President's Message by Joe LaViola: For five and a half years I have been privileged to serve as president of the UBBRG. Since the passing of Joe Campbell, Jerry Feldscher, Mary Pacifico, and John O'Brien; the executive board has been functioning without a Vice President or Travel Chair. These officers were a stabilizing force



which has been sorely missed. For the future of UBBRG, this is a matter of great concern.

The Blue Bell Retirees' formed in 1988 originally as a social group. It soon took on the matter to settle a dispute over medical coverage for Unisys retirees'. With this incentive, membership grew to

approximately 1800 members which resulted in substantial turnout for the meetings. The dispute has long been resolved and interest in the group has waned. Membership currently is at 637. This is because, "long time faithful members", whose numbers are declining, have continued to renew their membership. The marked reduction in Blue Bell retirees' and the lack of interest has greatly impacted the recruiting for new members. Although these numbers are impressive, the executive board has not been able to find anyone willing to become a member. To replace any of the executive chairs requires significant time and effort. This involves learning programs to: publish NEWSBITS, record membership details, keep the Website up to date, and manage the Treasury.

The executive board has not been able to overcome the afore-mentioned problems and met in January to discuss these issues. The following, while not easy to make, are steps the board has voted to take:

- UBBRG to be dissolved by December 31, 2016.
- Discontinue general meetings at Plymouth Mall.
- NEWSBITS and the <a href="http://www.ubbrg.org">http://www.ubbrg.org</a> Website will remain active through 2016.
- The executive board will remain active and will meet at regular intervals through-out 2016.
- Communication to the membership will continue through NEWSBITS and the ubbrg.org Website.





# **REPORTS, LEGACY ACTIVITIES**

May 'Article(s) for the Month': 1) A transcription of John Westergren's 2007 oral interview of Marc Shoquist. **Birthplace to Computer Hospice:** ERA, UNIVAC, and Sperry employees knew that Minnesota's computer industry birthplace was at 1902 Minnehaha Avenue in St. Paul Minnesota – January 1946. The Minnehaha address is the small building in the right center of this old aerial view.



Diagonally across this photo is/was the former glider factory in which most of the early ERA engineering, manufacturing, and testing took place. This building complex was designated ERA plant 1. Between the building at the top left and the factory was a railroad spur. In October 1950, ERA loaded the ATLAS I computer into a train car through the factory back doors for shipment to Washington DC. Classified at that time, this ATLAS I was the world's first 'stored program' computer delivered then operational in a customer's facility in December 1950.

In 1956, UNIVAC opened a new Twin Cities 'headquarters' building on Shepherd Road in St. Paul – the Minnehaha facility was re-designated as UNIVAC plant 2. The building in the upper left was later designated as UNIVAC plant 5 and the railroad spur disappeared. The back doors of the old glider factory became the passage way to the plant 5 – continuing into the UNISYS days in the early 90s when both plants 2 and 5 were vacated.

Today, 70-years since ERA started, the old glider factory back doors have a street address of 698 Prior Avenue. Stepping through these backdoors brought back memories of the high ceiling large area where UNIVAC had environmental test chambers in the late 60s and 70s for the CP-901 computers. I can still envision gliders being assembled in the area.

**Directions to UNISYS in Roseville:** Set your GPS unit to Roseville MN, 2470 Highcrest Road. <u>From Hwy 35W north;</u> exit onto W County Rd C to go west a mile, then turn left onto Walnut St. Then turn right onto Terminal Road for half a block, turn right at Highcrest Rd. to building entrance. <u>From 35W south</u>, exit on Industrial Way / St. Anthony Blvd off ramp, turn left, drive under the freeway, then turn right onto Walnut St. Follow it 0.8 mi north then turn left on Terminal Road. Go ½ blocks and enter the UNISYS parking lot on the right. <u>From Hwy 36 east</u>, drive west until 36 joins Hwy 35W just past Hwy 280, then exit at the Industrial



Way / St. Anthony Blvd. off ramp of 35W. Go north on St. Anthony Blvd. to Walnut St. [the first street on the right]. Turn right onto Walnut Street.

**Directions to Unisys MACS in Eagan**: Set your GPS unit to Eagan MN, 3199 Pilot Knob Road. <u>From Hwy 35E</u> take the Pilot Knob Road exit ramp. Then go north on Pilot Knob Road about ½ mile to Tower View Road. We use the Unisys north parking lot and the visitor entrance thereby.

**Directions to Highland Park in St. Paul:** Set your GPS unit to St Paul, 1200 Montreal Ave. From the Roseville area; take 36 to 35E going south through the city, exit at W 7<sup>th</sup> (Hwy 5) and turn right.
