As of June 1st, our VIP Club has 695 paid member units in 40 states, plus one each in Canada, Germany, and Greece! That is an amazing impact and it represents only paid members. Just imagine the footprint left by retirees no longer with us or who have not (yet \bigcirc) joined the club.

Reminder: Evite Adopted by the VIP Club Evite is a digital invitation and event management solution. The software allows event planners to create online invitations and ecards, notify and register event participants, and track RSVPs.

The VIP Club is using evite to notify VIP Club members with email addresses about near-term events. The VIP Club newsletter and website social page will continue to detail all our near-term and future events.

Evite recipients are asked to always RSVP, and reply to comments to answer requests from the event coordinator, such as food choice and payment requirements. A major evite benefit is that the "Guests" button allows invitees to see who else is coming to an event.

Evite also sends a reminder two days before the event. The host can then monitor responses in real-time

to assist in event planning, making a response of Yes, No, or Maybe from ALL invitation recipients that much more valuable and appreciated. Those with



e-mail addresses who do not want to receive evites can request to "opt out" by sending a request to membership@vipclubmn.org.

passed away on Sunday, May 10. Stan graduated from the University of Minnesota in 1952 with a BA in mathematics, then served in the U.S. Navy as communications officer on the minesweeper USS Endicott during the Korean War.

Once discharged, he returned to the University of Minnesota to pursue his master's degree, but upon the arrival of his first child he left academia. He briefly worked for Univac in the Twin Cities area before accepting an engineering position with RCA and moving his family to Delaware Township (later Cherry Hill), NJ. Not long after, he formed Ultronic Systems Corp. with several other former RCA employees, where he designed their entire stock market dissemination system for which he was awarded five U.S. patents. In 1968, Stan and colleagues founded his second and most successful company, Infotron Systems Corp. He grew the company from "three guys in the basement" to a multi-million dollar international corporation. Stan moved back to Minneapolis in the early 1980s and formed his third and fourth companies. He often said he "didn't know what he wanted to be when he grew up" and even until his death was working on complex mathematical challenges involving encryption. Stan was an uncommon individual who lived life on his own terms, never concerned about the opinions of others. He dearly loved and was generous to his children, but was also fiercely self-sufficient. Stan is survived by a brother, three children, six grandchildren, a nephew, two stepdaughters, and two great-grandchildren.

Larson, Dale Oscar – Passed away peacefully on May 1. Born in Iowa, Dale was a mechanical engineer graduate of Iowa State University in 1949. He worked at Maytag in Newton, IA 1949; then was a Sgt. Army Ord. White Sands, NM 1950. He worked in computer research and development at Engineering Research Associates (ERA), St. Paul 1952; Maico, Minneapolis 1958; Control Data/Ceridian 1960-1989. Taking the next several years to teach himself computer programming, he was hired in 1968 as a systems programmer, Employee 49, at the newly founded Comcet, Inc. (eventually acquired as NCR Comten, Inc.). During the following three decades, Vern would himself premier distinguish as a software engineer/architect in the Twin Cities, earning multiple Outstanding Technical Achievement awards, the Chief Scientist's Eureka Award, and two top Laureate Awards for Continuing Outstanding R&D Contributions at NCR. Vern suffered a stroke in 2001 resulting in partial paralysis and aphasia. With his ingenuity and tenacity, he was able to maintain relative independence for the next 18 years, including reworking his apartment setup by building custom shelving and setting up a personalized, remote-controlled lighting system. Vern will always be remembered for his brilliance, work ethic, and determination, always encouraging continued He is survived by two children, two learning. grandchildren, and two sisters. He is preceded in death by his wife, Judy Jablonske, whom he married in 1965.

Loughney, Mary Frances – Age 95, passed away June 15. Mary grew up on a dairy farm in Hudson, WI, began her working career as a governess, then became a bookkeeper and supported the war effort at the Twin City Arsenal. In

Peterson, Melvin C. (Mel, Pete) – On Monday, May 4, Mel passed away at the age of 76 from complications related to Parkinson's disease. Mel was born on January 21, 1944 in Cumberland, WI. Shortly after graduating from Wisconsin



State University, River Falls, he moved to Huntsville, AL to work for Boeing on the development of the Saturn V rocket. Upon moving back north to the Twin Cities, he began a career as a software engineer with Univac that lasted more than 40 years through multiple company name changes, ending with Unisys Corporation. He spent a number of years living in London, England and Zürich, Switzerland working directly with clients, and his intelligence, work ethic, and honesty earned him respect throughout his professional career.

Mel was quiet and kind, with a dry wit and quick laugh. Growing up on a farm, he quickly learned the value of hard work and self-sufficiency, and built his first house with his own hands. He loved classical music, especially opera, and for many years maintained season tickets to the Minnesota Orchestra. He also enjoyed photography and researching his family genealogy, traveling to Sweden to research his origins. He was enormously proud of his work in the space program, and that his name was entered into the Apollo/Saturn V Roll of Honor, a copy of which resides in the Library of Congress. Mel was a longtime member of Bethlehem Lutheran Church in Minneapolis, where he served as an usher. In retirement he enthusiastically volunteered for Meals on Wheels. careers, but Rollie was defined by his commitment to family, his faith in God, and his willingness to give to others when he had little to share. As a teenager, he quit school to help his parents support the family. Once he was married, he worked as an engineer and a farmer, both jobs necessary for a family with eight children.

Rollie was a child of the Great Depression, with all the hardships that entailed. He grew up speaking German in Pierz, MN, learning English in first grade at the one-room schoolhouse. But high school wasn't in his future; he instead helped on the family farm, then took a factory job in St. Paul. He changed his life's trajectory when he joined the air force division of the U.S. Navy during the Korean War. The coursework he took while in service allowed him to earn his high school GED in 1955. After his discharge, Rollie moved home and met Dorothy Ella DeMarais, who became his lifelong love and wife of more than 60 years. He enrolled at the Milwaukee School of Engineering and soon joined then-Sperry Univac as a manufacturing engineer, using every spare minute to run the small farm near Corcoran he bought with Dorothy in 1969. At age 56 he turned to full-time farming.

Rollie could fix anything, from a tractor engine to the foundation of a house. He was a lifelong learner who shunned television and spent rare leisure time reading. He was the go-to parent for help with math homework. He found joy in his old-time music and played piano and button accordions, often with a child happily dancing to his songs. In retirement, he always had a project going, whether refurbishing an antique riding lawn mower or remodeling the barn for family weddings. Rollie was preceded in death by his wife, Dorothy, and is survived by 8 children, 15 grandchildren, 8 great-grandchildren, and 3 siblings.

Vizanko, Donald "Buzz" – On June 13, loving husband and father passed away at the age of 99. Don was born November 6, 1920, in Washburn, WI. He served his country as a U.S. Navy



radio specialist and Radar officer stationed in the Philippines during WWII. He earned his engineering degree with the GI Bill from Montana State in Bozeman, MT.
