HEALTH ISSUES 13 March 04

In today's Minneapolis Tribune, Mayo's CEO is another of the mid-west voices telling us that Medicare doesn't cover the full cost of patient treatment. Dr. Denis Cortese says, "We need to redo the way we practice... We will have patients who are living longer, have more chronic diseases and more complicated diseases."

We also have a Medicare system that is making things worse for Minnesotans. One doc said anyone who has health problems and didn't spend half the year in Florida was missing out on serious savings. In a "market basket" approach for a Hennepin County HMO enrollee, the cost difference is \$5,843. A Minnesota resident would pay \$1,153 in premiums, \$600 in copays for 20 clinic visits and transport, the full \$3,500 for prescription drugs, the full \$200 for eyeglasses, and \$450 as a 50% copay for a \$900 hearing aid – a total of \$5,903. In Dade County, Florida, only \$60 in copays for \$500 in branded drugs was needed, Medicare covered all other costs. (Look for your next month's Senior Federation Newsletter for more information.)

Canada is still suspect as a source of unsafe drug, yet the articles seem never to mention that the drugs ordered from Canadian pharmacies are almost all "maintenance" drugs that are used daily for chronic conditions and are in their original manufacturer's packaging. Packaging with an easy to read label and an easy to open screw top. We should thank the Canadians for their conservative use of drugs. An ABC report tells us the 31 million Canadians use 2% of the world output; the less than 300 million Americans use 44%.

For U of M alumni, the spring 2004 newsletter has a lead article on why drug prices are so high, and why that is such a growing problem. Dr. Steve Schondelmeyer, the U's pharmaceutical industry guru, says the drug companies began pricing drugs based on a country's median income. Prices are 50-60% of the U.S. in Canada and 40-50% in Europe. With the huge income disparities in the U.S., those

of us with HMO or other coverage are insulated from those high prices, but those paying the full cash price are the poor and the elderly.

Here's something else to think about. The new Medicare benefit for 2006, the one that the Congressional Budget Office says won't save the government any money, is called Medicare Part D. The reason it can't save the government any money is because the government has made the private insurers responsible for doing the negotiating and saving us money. Right!

At the state level, the Minnesota Academy of Family Physicians March Newsletter tells us the Governor is proposing transfer of \$70 million from the Health Care Access Fund to help take care of the State's \$160 million budget shortfall. This is the fund that takes 2% from the medical community for the Minnesota Care program to help low income patients. Pawlenty's budget wants to use it for roads, schools, and other general fund programs. Last year the Legislature transferred \$190 million out of the Health Care Access Fund to help balance his budget.

Help From The Sun By Brian Berggren

At a get-together back in February, the hot topic was heating bills. Oh, ain't it terrible everyone said. I said our electric bill was \$87.31 for December, and that included heat, lights, hot water, and everything else (the heat part was \$47.70). For not suffering with a high enough bill, I was ignored.

The house is the story. The sun heats it through the south-facing glass. On a bright January day the temperature inside will reach the mid-70's, even when it is 15-20 below zero outside. By the 10 o'clock news the temp will have fallen to the mid-60's.

The thermostats turn on the heaters at about 61 degrees, so mornings are a bit cool. When the sun doesn't shine, we light a fire in a small Danish wood stove. Our electric heat energy costs for last year total \$234.83 (Nov-\$28.30, Dec-\$47.70, Jan-\$43.26, Feb-\$62.28, Mar-\$41.33, Apr-\$12); this is for 4217 KWH of electricity. For the stove we burn a little

better than a cord a year, all wood from the yard. We also burned 150 pounds of shelled corn (three bags at \$4.19 each).

We heat 3400 square feet with 800-watt electric radiant panels, plus keep a triple garage above freezing with a 1300-watt milk-house heater. But the sun provides most of the energy and our plants seem to like the temperature swings between cold mornings and warm afternoons. And we accept the bleaching job the sun does on fabrics.

A secondary benefit is summer air-conditioning. Using a 5000 btu window unit to cool and dehumidify, our cost was \$36.

Help your children avoid inefficient homes. Help them find homes with windows rather than garages on the south side. Use shades and drapes to keep the heat in, not the sun out. Then they can mention how little energy they use and be shunned.

Directions to Eagan Community Center. Take Hwy 35E south or north to Pilot Knob Road. Turn left (north) on Pilot Knob Road. Turn left on Central Parkway (which is also the North entrance to Lockheed). The Eagan Community Center is at 1501 Central Parkway.

Directions to Unisys in Roseville. Take Hwy 35W south or north to the Industrial Way / St. Anthony Blvd off ramp. If coming north or south on Hwy 35E go west on Hwy 36 which will take you to the Industrial Way / St. Anthony Blvd. off ramp of 35W (Hwy 36 becomes Hwy 35W where it joins Hwy 35W). Go north on St. Anthony Blvd. to Walnut St. (the first street on the right). Turn right and go to Highcrest which is the first place where you can turn left. Past the stop sign. Bldg 3 is on the right. Gate 5 is in the center of the building.

From Hwy 280 northbound, use left lane exit just past Cty Rd B for Terminal road access (St Croix St.). Turn left at Terminal Rd, then turn right at Highcrest Rd to building entrance.
