HEALTH ISSUES

The Medicare Bill: AARP and Congress

Have you burned your AARP card? Have you made a voodoo doll of your congressman? Two recent articles tell much about how a law so important to seniors was hijacked by inside-the-beltway interests and practices that largely ignored seniors.

The Seduction by Barbara T. Dreyfuss (American Prospect, June 2004, p18-23) describes AARP's fall

as a senior's advocate and Democratic ally. AARP was never really militant and was founded in 1958 as an insurance business. Insurance royalties provided 24% of its income in 2003 (39% in 2004). While AARP CEO Bill Novelli was letting Democrats think he was with them, his policy chief sent an email to a presidential health policy assistant suggesting "fairly moderate ways for handling the biggest issues." With the knowledge that AARP was so pliable, House Speaker Hastert and Senate Majority Leader Frist worked with AARP leaders to make the final bill.

Least surprised was Newt Gingrich who has spent the last nine years working on AARP. He states Novelli "has a long history of supporting individual responsibility in health care and doesn't want seniors dependent on government handouts."

Already by 1997 the Balanced Budget Act made program cuts and the major leap of opening Medicare to private insurers. It was in this period that AARP went from Democratic-leaning to bipartisan and worked closely with then-Speaker Gingrich. Remember, AARP was very quiet on health-care reform and Medicare prescription drug benefits, and gave very little support to the Clinton Health Security Act.

With Horace Deets thinking of retiring, he brought Novelli in to oversee public policy, communications, and advertising. With a boost from Gingrich and the feeling Republicans would soon be setting the agenda, Novelli was picked by the board to succeed Deets.

Novelli moved to isolate the central staff from regional offices and activists. No more "grass roots – it's dictated from the top, not from the bottom. To complete policy control, Novelli eliminated any connection between the board and the membership, and with it the national convention delegate's election role. A self-selecting nomination committee picks his board. AARP's support of the bad law shows it again as an insurance marketer with its own advertising arm, the magazines we expected to champion our issues.

The second article, Democracy on Drugs, is a frightening report from Common Cause. It is dated May 18, 2004, and subtitled The Medicare/Prescription Drug Bill: A Study in How Government Shouldn't Work. The report chronicles incidents that show "the Administration and Congressional leadership bypassing or undermining rules and laws that (were intended to) ensure an open and accountable government."

Our Constitution sought to give voice to the minority, even with a strong majority in control. But

bribery charges, delayed votes, censoring of cameras, withholding of cost estimates, and exclusion of those critical of the bill from the conference committee left the minority with no power. One house author was forced to step down and an administration official criticized for negotiating lobbying jobs while working on the bill.

Rep. Nick Smith was told \$100,000-plus would be given to his son's congressional campaign if Smith would vote for the bill. When the bill was up for the big vote, the House leadership held the vote open for three hours (15 minutes is more the rule) while leaders did their arm-twisting. During this period, the C-SPAN cameras were fixed on the Democrat's side of the House. Normally, the cameras focus on whoever is speaking or just scan the whole floor. There is now no visual record of who was talking to whom. Another atypical happening was the appearance of HHS Secretary Thompson on the floor to lobby for his bill.

Back in June of 2003, HHS chief actuary Richard Foster was predicting the prescription drug benefits would cost \$156 billion more than the \$395 billion working estimate. Foster was told under threat by Medicare administrator Tom Scully's assistant that no numbers were to be shared with Democrats. Following passage of the differing House and Senate versions of the bill, House Ways and Means Chair Bill Thomas said, "This (conference committee) meeting is only open to the coalition of the willing." He then excluded Rep. Wrangle and four other critical Democrats.

Within days after passage of the bill, Medicare chief Scully resigned to take an already-negotiated job with a law firm that represents hospitals and drug companies. At the same time, Rep. Billy Tauzin had negotiated a \$2 million a year package to lobby for PhRMA, the drug manufacturer's trade group.

Maybe crime doesn't always pay, but a really flexible set of ethical standards and an indifference to the well-being of the people our officials are supposed to serve seems to pay just fine. Written by Brian Berggren



Directions to Eagan Community Center. Take Hwy 35E south or north to Pilot Knob Road. Turn left (north) on Pilot Knob Road. Turn left on Central Parkway (which is also the North entrance to Lockheed). The Eagan Community Center is at 1501 Central Parkway.

Directions to Unisys in Roseville. Take Hwy 35W south or north to the Industrial Way / St. Anthony Blvd off ramp. If coming north or south on Hwy 35E go west on Hwy 36 which will take you to the Industrial Way / St. Anthony Blvd. off ramp of 35W (Hwy 36 becomes Hwy 35W where it joins Hwy 35W). Go north on St. Anthony Blvd. to Walnut St. (the first street on the right). Turn right and go to Highcrest which is the first place where you can turn left. Past the stop sign. Bldg 3 is on the right. Gate 5 is in the center of the building.

From Hwy 280 northbound, use left lane exit just past Cty Rd B for Terminal road access (St Croix St.). Turn left at Terminal Rd, then turn right at Highcrest Rd to building entrance.
