LEGACY NEWS UPDATE

The Legacy Project was initiated by Lockheed Martin MS2 in 2006 with VIP Club Support to document its 60-year Information Systems Legacy. This Legacy began with the founding of Engineering Research Associates (ERA) in 1946 in St. Paul and the development and applications of computers in Defense Systems Projects. This Legacy today is resident in Lockheed Martin MS2 in Eagan, Minnesota. In support of this project, VIP Club Director Lowell Benson developed a Legacy Website which is hosted on his personal website. The *Legacy* Website is the vehicle to document this 60 year Legacy. The Site Map identifies nine areas for gathering pertinent Legacy information. These are: Legacy, Artifacts, Careers, Computers, Facilities, Hardware, Software, Support and Systems. LM Eagan Legacy Website – Progress Continues Admirably

The Legacy website has seen some interesting, informative, and enticing additions in the last month. Taking it from the top, as in top management, be sure to check out the "Presidents List,' recently provided by Lowell Benson. From 1946 to today, this list presents the leaders of the St. Paul organization in chronological order. If you can fill in some missing data or provide any corrections, please contact Lowell at <u>labenson@usfamily.net</u>.

Other great additions have been supplied by Marc Shoquist, John Byrne, Jim Rapinac and Bob Blixt. Marc Shoquist provided "The Antenna Coupler Program," the critical revenue generating program that allowed ERA to survive and eventually grow as the St. Paul computer pioneer. Marc recalls the history of the Coupler, its technical aspects, and the personnel involved, as well as his travels with Fred "Hargy" Hargesheimer. The Fred Hargesheimer story itself is a not-to-miss highlight of our legacy. John Byrne's "Early Memories of an Old Programmer" is a fascinating piece on software development in the early days of assemblers and compilers, including customer pressures, fledgling software and hardware, shipboard systems, and all in historical perspective. Jim Rapinac's input is entitled "Anti-Submarine Warfare - A History of the Relationship between Sperry Univac Defense Systems Division and Lockheed California Aircraft Company." It could be a stand-alone chapter in the legacy of involvement between Lockheed California Aircraft Company (CALAC) and Univac. What an amazing breadth of knowledge for company history and customer (USN - NAVAIR) history, as well as competition and key personnel. Bob Blixt's write-up, "P-3C Early Computer Development at Univac," describes the conception-toproduction process for the CP-901 Computer and its operational software. This system has truly stood the test of time of a generation in the fleet of P-3C ASW aircraft.

Legacy the Website, or Legacy the Book?

The LM Legacy website is clearly off and running and gaining momentum. In addition, some Legacy committee members have suggested capturing our history in book form. Consider the following. If we were to print the web site as a first draft, it would be just over 150 printed pages. Eliminating the web navigation buttons and headers would give a 100 page second draft. HEALTH ISSUES

Your standalone Medicare Part D options just got bigger; Minnesota residents now have 53 plans from which to choose, up from this year's meager list of 41 plans. You should also note that Part D premiums are expected to rise 13.4 percent, along with the deductibles, co pays, and donut hole amount. In addition to the 53 standalone plans, we also have 44 Medicare Advantage plans with drug benefits-up from 22 this year.


At the October Medicare Justice Coalition meeting, we heard that the GOP leadership has told congressmen to plan on staying in D.C. to do their Christmas shopping and serious lame duck legislating. Many of the Coalition members are hoping that the 5.1 percent physician payment reduction will be eliminated before the new year so the payers and providers won't have to redo so much of their financial planning. (This amounts to \$5 billion in cuts to physicians over the next 10 years and could be taken from the \$10 billion slush fund to "encourage multi-state payer (like Humana) competition.")

Two other hoped-for Medicare changes are delaying the Part D enrollment penalty until the number of plans and costs settle down and legislating a real drug reimportation law that might even allow out-of-country drugs to count toward the Part D tally. Given that this congress has failed to pass anything meaningful on anything, I'm more afraid that the leadership may give us only quickie legislation for special interests that will take more time to get straight.

Semi-Politics

Some of you may remember the October 17 visit to the Rosemount VFW Post by Representatives John Murtha and Jim Oberstar on behalf of Coleen Rowley. The part that made both the Star-Tribune and Pioneer Press was the name-calling and car pointing by Rep. John Kline's state director and his group of protesters. What didn't get any press coverage was Murtha's talk on the backdoor draft, misuse of the Reserve and National Guardsmen sent overseas, and the problems and costs of the returning injured.

Directions to Eagan Community Center. Take Hwy 35E south or north to Pilot Knob Road. Turn left (north) on Pilot Knob Road. Turn left on Central Parkway (which is also the North entrance to Lockheed). The Eagan Community Center is at 1501 Central Parkway.

Directions to Unisys in Roseville. Take Hwy 35W south, or north, to the Industrial Way / St. Anthony Blvd off ramp. If coming north or south on Hwy 35E go west on Hwy 36 which will take you to the Industrial Way / St. Anthony Blvd. off ramp of 35W (Hwy 36 becomes Hwy 35W where it joins Hwy 35W). Go north on St. Anthony Blvd. to Walnut St. (the first street on the right). Turn right and go to Highcrest Road. It is the first place where you can turn left. Past the stop sign, Bldg 3 is on the right. Gate 5 is in the center of the building. From Hwy 280 northbound, use left lane exit just past Cty Rd B for Terminal road access (St Croix St.). Turn left at Terminal Rd, then turn right at Highcrest Rd to building entrance.
