REPORT, WEB SITE REVIEW

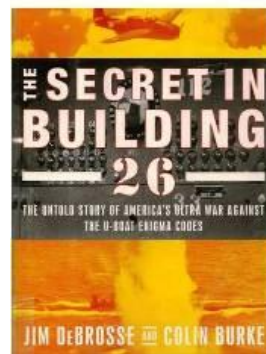
This is the twenty-ninth in the 'Article-for-the-Month' review series for Club members without immediate internet access. By Lowell A. Benson

Collin Burke, co-author of "The Secret in Building 26" was the featured speaker; I provided the ERA to LMCO perspective. WHY? Col. Don Patton, coordinator of the Round Table series, invited the VIP Club's participation as a complement to the speaker. Bldg 26, located in Dayton, OH was the location that the Navy used during WWII to build electronics used for code busting. Our second slide has the words:

- "As WW II ended, the Navy, concerned that the makeup of the CSAW team be preserved in peacetime, offered civil service appointments to several members including Engstrom and Norris - Engstrom suggested that they form a private company.
- They were joined by a new partner, Capt. Ralph I. Meader, who had headed the Naval Computing Machine Laboratory (NCML) which manufactured devices for CSAW at NCR in Dayton, Ohio.
- The result was Engineering Research Associates (ERA) located in an old glider factory in St. Paul, MN."

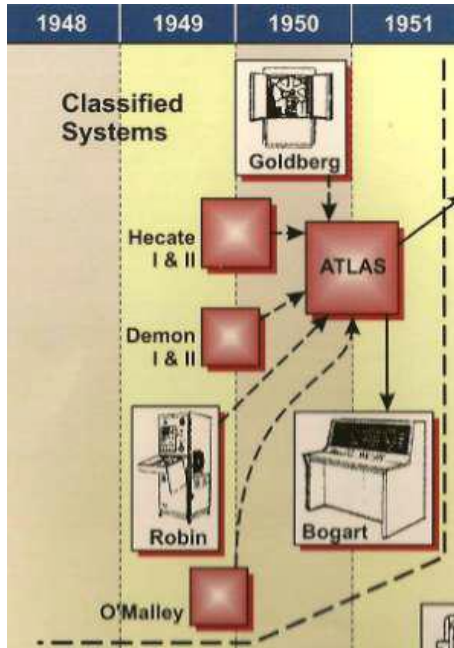
Yes, our founders were involved with 'code breaking' and classified work before ERA so it is no wonder that ERA's first few analytic machines have little or no published data. Chapter 3 of "When Computers went to Sea" by Capt. David Boslaugh talks about the founder's history thus is recommended reading.

Only half a dozen of the 250 attendees were VIP Club members so these two bullets were quite apropos:

- A 66-year LEGACY of Defense Industry Information Technology (IT) developments and applications started in 1946 with Engineering Research Associates (ERA) at 1902 Minnehaha Avenue in St. Paul, Minnesota. This

Information Age Legacy merged and diverged through the corporate ownerships of Remington Rand, UNIVAC, Sperry, UNISYS, PARAMAX, Loral, and Lockheed Martin.

- In 2005 the VIP Club & LMCO began a Legacy Committee – collecting artifacts and documenting the ERA IT Legacy as a web site anthology; over 250 ex-employees have contributed their career summaries and/or project/product stories.



In April 2012, we posted [“CREATIVITY-SUCCESS-OBSCURITY, UNIVAC - What Happened?”](#) by Gerald E. Pickering. “A fellow retiree posed the question of what happened. **How did the company that invented the computer snatch defeat from the jaws of victory?** The question piqued my interest, thus I tried to draw on my 32 years of experiences in the company and the myriad of information available on the Internet to answer the question for myself and hopefully others that may still be interested 60+ years after the invention and delivery of the first computers. Computers plural, as there were more than one computer and more than one organization from which UNIVAC descended.”

“Though *IBM and the Seven Dwarfs* may have been a whimsical play on words in the early 1960’s, UNIVAC was head and shoulders above the other six dwarfs. Though IBM may have enjoyed greater revenue and greater profit, in no way did UNIVAC yield superiority to IBM in military business, large scale mainframe and real-time and communications computers, or the share of commercial computers sold to the federal government.”

“This story concludes with a detailed account of my work assignments within UNIVAC. The reader can determine for himself what creditability I personally bring to the accounting of this story of UNIVAC and the industry. The reader should know that I am an octogenarian, retired from the company for 22 years. Recollections of events no doubt have faded over time and my relationships with people, inside and outside

the company, friendly or adversarial have influenced my perspective and impressions.”

REPORTS, ACTIVITIES

Lockheed Martin Update: by John Westergren
I’d like to share a little of what’s happening here in Minnesota with the closure of the Lockheed Martin MS2 Facility in Eagan and how that is influencing the Club’s IT Legacy activities.

1. About a 1,050 employees were affected by the closure that was announced two years ago. Some are staying on with LMCO, but others are moving on to retirement or other jobs – some reluctantly. One of the things it has done is caused everyone to clean out their area and the rest of the building since we’re moving out. The Legacy Committee has gathered a huge amount of historical and archival information that we have arranged to have protected for the future with two local organizations: the Charles Babbage Institute (CBI) Center of the History of Information Technology at the University of Minnesota and the Dakota County Historical Society (DCHS) Research Library and Museum.

a. We have already provided a number of items to CBI like the entire set of Engineering Log Books from the Sperry Research Center in Sudbury, MA; some of the original disclosures and patent information from the early years (1946-50’s) of the digital age documenting the first computing machines; and photographs of technology, employees, and products from the our history. Over the next two months we will be providing them many more boxes of documentation that we’ve found and is worth saving.

b. Since CBI is only able to receive and store documents, DCHS will be the recipient of some of the “three dimensional” items from marketing trinkets from the past, to a few old and no longer in use computers and products. The Legacy Committee has also been cataloging thousands of photographs from our photo archives and DCHS is providing space for that effort to continue. DCHS’s goal is to create a semi-permanent exhibit depicting the history of Lockheed Martin and its Legacy Companies here in Minnesota with of goal of having that open in 2014.

2. Things we do today will be history to the people of the future. We have made arrangements with Records Management that selected historical items will be able to be retained in Iron Mountain for a

designated period and when appropriate, be brought out for disposition to one of the above organizations after final review and approval. We did not want to lose recent history.

3. An additional item. As people have been leaving over the course of closing this facility, at the end of every month some gather at a local establishment with friends for one last “goodbye”. In October, since the number of departures was more than usual (65), some of us decided it was still a good idea to gather, but we needed a little larger area. So we made arrangements for dinner, music, dancing, and refreshments at a location and about 325 employees, former employees, retirees, and significant others came for a gathering of some of the best people you’d ever want to work with. We finally had to ask the last 25 dancers and talkers to leave about 11:45pm. Keith Myhre has provided some snapshots, see pages 6 & 7.

When the Legacy Initiative started, we here didn’t realize how important it was going to be to acknowledge our history. Trust me, it is very important to many people – keep it up! Regards, John Westergren

Found in the Archives: by Harvey Taipale

Remington Rand Univac was in all the local papers [remember when we had 4?] in September of 1956 when this photo was taken.



The first 1103A computer was being loaded for shipment to the Lockheed Aircraft plant in Palo Alto California, to be used for simulating flight of new aircraft, rocket, and missile designs. Lockheed Aircraft is one of the key predecessor companies of Lockheed

Martin, who is now in the process of dramatically downsizing its Minnesota presence.

The 1103A was an upgrade of the 1103, replacing the Williams memory tubes [a Cathode Ray Tube (CRT)-based electrostatic memory] with the then new core memory technology. Billed as the fastest machine at the time, the 1103A could add 30,000 36 bit words per second, and had a memory fetch and write time of 8 microseconds. This 1.5 million dollar machine, when finally installed with its complement of card readers and punches, tape and drum memory, and printers, was 56 feet long, 10 ½ wide, and weighed 17 tons. Its circuitry included over 5000 vacuum tubes and 9000 diodes. It consumed 100,000 watts, and its air to water cooling system was big enough to handle “eight Texas homes.”

Loading is taking place at the Griggs Midway Building on Fairview and University Avenues, then known as plant 4. The semi truck is one of two that were required for the shipment. The newspaper articles were published on Wed, Sept 5, and the units were expected to arrive at Lockheed by Sept 10th and be in operation by October 15th. The articles also mention that a future unit was to be delivered to Ramo-Wooldridge Corp in Los Angeles [one of the predecessors of TRW] for work on the “intercontinental missile effort.” A Ramo Wooldridge unit eventually ended up at the University of Minnesota.

Unihogs/Uniturkeys: Thirty-nine of us met at Casper’s on November 16. Bernie Jansen presented the plans for our IT Legacy exhibits at the Dakota County Historical Society’s Lawshe Museum. His slides are on our website’s December Article for the Month.

Southern Suburb Information: by Lowell Benson There's a new study beginning this fall - MnDOT, in cooperation with Dakota and Scott counties, and the cities of Burnsville and Savage, has initiated a study to provide updated guidance for transportation improvements along Hwy 13 through Savage and western Burnsville. The plan is to create concept alternatives keeping focus on lower cost/high benefit solutions to the highest risk areas, addressing safety and mobility of passenger vehicles, transit, heavy truck movements and pedestrians/ bicyclists. DIRECTIONS TO ACTIVITY SITES

Directions to Unisys in Eagan: Set your GPS unit to 3199 Pilot Knob Road, Eagan MN. From Hwy 35E take the Pilot Knob Road exit ramp. Then go north on Pilot Knob Road about ½ mile to Tower View Road. We use the Unisys north parking lot and the visitor entrance thereby.

Directions to Unisys in Roseville: Set your GPS unit to 2470 Highcrest Road, Roseville MN. From Hwy 35W north, exit onto W County Rd C, go west a mile, then turn left onto Walnut St. Then turn right onto Terminal Road for half a block, turn right at Highcrest Rd. to building entrance. From 35W south, exit on Industrial Way / St. Anthony Blvd off ramp, turn left, drive under the freeway, then turn right onto Walnut St. Follow it 0.8 mi north then turn left on Terminal Road. Turn go ½ block and enter the UNISYS parking lot on the right. From Hwy 36 east, drive west until 36 joins Hwy 35W just past Hwy 280, then exit at the Industrial Way / St. Anthony Blvd. off ramp of 35W. Go north on St. Anthony Blvd. to Walnut St. [the first street on the right]. Turn right onto Walnut Street. From Hwy 280 northbound, use left lane exit just past County Rd B for Terminal road access [St Croix St.] Turn left at Terminal Rd, then 1.5 mi to the Highcrest Rd entrance.

Directions to the Officers' Club: Set your GPS unit to, 5512 Post Road, St Paul MN. The Club is located on a service road off of Minnesota Highway 5, at the east side of the MSP airport. Take the Hwy 5 Post Road Exit at the southeast corner of the airport, go east then follow the signs to the Officers' Club. There is limited parking on the upper level with additional parking on the lower level, car-pool if possible.
