# **Addressing Obituary Inquiries**

We have received inquiries about including obituaries of deceased people from the 90s. The earliest obituaries that we have in our newsletter archives are from 2004. Read on for the history of VIP Club newsletter obit lists:

- At the annual Unihogs meetings, the group used to read names of 'UNIVACers' or CDC or ... people whom the planning committee identified as having passed away. I had joined that planning committee in 2000. In 2006, I read the club newsletters for obits to note at the Unihogs meetings (<a href="https://vipclubmn.org/activities.html#Hogs">https://vipclubmn.org/activities.html#Hogs</a>). After merging the Legacy web pages with the club website in 2007, we started to archive newsletters on the web (<a href="https://vipclubmn.org/newsletters.html#Archives">https://vipclubmn.org/newsletters.html#Archives</a>). Then, in 2008, we started a 'People Deceased' page
  - Then, in 2008, we started a 'People Deceased' page for the Legacy Anthology chapters (<a href="https://vipclub.mn.org/deceased.html">https://vipclub.mn.org/deceased.html</a>).
- About 2010, I:
  - Received electronic newsletter copies back to 2004 from Joe Schwartz, so added them to the newsletter archives page
  - Made .pdf files of the Unihogs annual lists that I still had and appended them to the archives' annual entries
  - ♦ Made obit lists from the newsletters back to 2004 and added them to the archives.
- The Roseville luncheon group (<a href="https://vipclubmn.org/activities.html#Unisys">https://vipclubmn.org/activities.html#Unisys</a>) led by Marv Brown read deceased names at their monthly luncheons. Paul

- Dickson took over as emcee in 2020 as Marv had to cease hosting after 28 years. Paul alphabetized Marv's deceased list and sent it to Lowell. Lowell merged the annual obit lists from the archives and posted it for members to read online.
- In 2020, Jim Andrews took on the responsibility for generation of the annual obit lists. He now updates the list every two months keeping up with the obits in each newsletter. Note that he also updates a list of the deaths reported for the current year. The link can be found on the website's Newsletter page at the end of each year of archived newsletters. Jim noticed that the club's database had some spouses noted as deceased, however no obits had been reported, thus not included in the newsletter. He has added those to the alphabetical list. Unfortunately for those entries we do not have the deceased dates nor ages of their passing. The current list as of the Jul/Aug 2024 newsletter is 40 pages, available for download from https://vipclubmn.org/PeopleDocImg/ AlphabeticDeceasedEmployees.pdf.

# Nostalgia

At the Legacy Committee's first meeting in January 2006, we resolved to tell the then-to-fore (*obsolete, rare*) untold story of Engineering Research Associates (ERA). Now, it's been 78 years since ERA pushed the power button to ignite Minnesota's computer age. The top five Legacy Committee accomplishments, in Lowell Benson's opinion:

- 1. The Twin Cities Public Television (TPT) in partnership with the MN High Tech Association produced a 'Solid State: Minnesota's High-tech History' documentary. It was filmed at TPT studios, the museum, a VIP Club picnic, and a few other MN sites. Narrated by Dr. Tom Misa, it includes eight Legacy Committee member interviews.
- 2. The Dakota County Historical Society (DCHS) Lawshe Memorial Museum in South St. Paul has more defense-industry computer artifacts than any other museum in the world!
- 3. Our Legacy Anthology website has 636 contributors and includes 211 career summaries plus over 200 monthly articles.
- 4. The committee's cooperation with the Ramsey County Historical Society (RCHS) 2023 event that recognized ERA's founding in St. Paul with a commemorative plaque at 1902 Minnehaha Avenue.
- 5. Working with the local Unisys management to preserve the computer history shadow boxes when the Roseville plant closed in 2017. We will continue this preservation by transitioning the shadow boxes to RCHS in 2025.

# **YOUR STORY**

#### **Aircraft Carrier Ride**

My most memorable event occurred early in my 37-year career at UNIVAC/Lockheed Martin. In 1966, Mike Kokesh and I were given the task of writing comprehensive System Alignment Test (SAT) programs for the radars and sonar aboard the Destroyer Escorts (DEs) 1047/9 and the CVS-18. The CVS-18 was the aircraft carrier USS Wasp that became famous for recovering the Gemini astronauts whenever and wherever they landed in the ocean. Developing these sizable programs from scratch by two relatively inexperienced programmers proved rather challenging and probably was my most difficult assignment in my years at the company.

Finally, in March 1968, we were called to ride the

CVS-18 from the Boston Naval Shipyard down to Atlantic Undersea Test and Evaluation Center (AUTEC) range in the Bahamas for Sea Trials. On the way down, the ship experienced a very bad three-day storm (70-knot winds and 25-foot waves); the ship and its aircraft suffered some damage. After safely traversing the worst of the storm, the ship received a distress call and the captain ordered the ship to turn back into the storm. The ship's helicopters were ordered to airlift the crew off of a merchant tanker at risk of breaking up in the storm. The rescue was performed under dangerous conditions, but was successful. The coordinating S-2 aircraft, on returning to the carrier, crashed very hard on the rolling flight deck, tearing off its landing gear and antenna, setting off the flares in the aircraft nose, and rupturing its fuel tanks. By some miracle, the aircraft fuel flowed down the deck of the pitching, rolling ship in the opposite direction of the burning flares.

On arriving in the Bahamas, I was requested to meet with the carrier operations officer, who was a commander and the third ranking officer on the ship. He immediately asked me what my plan was for the ship's course during the tracking and alignment testing of the three search radars, the four Gun Fire Control System (GFCS) radars, and the sonar system. I then asked him what he recommended. He briskly replied, "You are the UNIVAC engineer. You tell me. I can drive this carrier any way you want me to." Quickly making up something, I said, "How about a figure eight going out 10 miles 10 knots in both directions from the buoy target?" (The buoy target contained a radar reflector and a sonar transponder). "No problem," he said. "Be in the CIC (Combat Information Center) and ready to go at 0300 and we will run your test."

At 0300, Mike and I very nervously started the test with CIC display consoles manned and several officers observing. Within a short while complaints started coming in that the GFCS radars could not maintain track. Because of the several-foot-high waves, they would lose the target. The sonar operator complained that he lost contact with the transponder because it was too far away.

The CIC officer turned to me and said, "Your test is no good, it is not working. What do you want to do now?" I nervously responded, "Uh, uh, can we try a figure eight at 5 miles and 5 knots?" He immediately phoned the Bridge and said, "The UNIVAC engineer wants the ship moved in to 5 miles and at 5 knots." Soon I could feel the carrier turning. I looked up at the heading and speed gauges, and the carrier was turning and slowing down. "Wow, I thought to myself—I am in control of an aircraft carrier!"

Soon the sonar and GFCS operators each reported in that they were now tracking the target with no

problem. At the end of the SAT test, we typed out the results and they showed that the navigation radar (SPS-10) had a 2.6-degree alignment error. The CIC officer looked at the results and said, "Your test is not any good. There is no way our 'Nav' radar has such an error." He then phoned the navigation radar operator who arrived shortly. He took one look at the test results and said, "This is good information. I always thought my radar was off two or three degrees. I know you are right. I'll correct the alignment of the radar right away."

For the next two days, Mike and I were able to relax and watch the daily flight operations. Then we got to be catapulted off the carrier in an S-2 aircraft and were flown to Miami International Airport.

After a colorful history, the USS Wasp (CVS-18) was officially decommissioned on 01 July 1972, then subsequently sold for scrap. The WASP SAT program was later modified by Don Lovely and installed and used as the Radar Alignment Test (RAT) program on the German Destroyers DDG-28/29/30. Larry Duder later modified and installed the RAT on the Japanese Navy DDG-168/9 ships.



Ross was a Master Mason, and in his spare time loved tinkering with radios, televisions, and computers. He loved music, was an avid history reader, and had a dry sense of humor. Ross was preceded in death by his wife, Glennie, and is survived by a daughter and granddaughter.
